

Distinguished Member,

The 2009-2010 ordinary general meeting of the property owners of Dağcılar Site was held on 04.07.2010 on Sunday at the site's cafeteria. At the end of the meeting, the following decisions were made.

Cemil Keser was elected as the chairman of the board; Umran Yılmaz and Salih Kendir were elected as the secretary members. The study report including the activities performed within the year was read by the Chairman of the Board after reading the agenda. The most important topic was that after the 228 m. digging work, 4 inch water was found, which means that water problem of the site was completely solved.

In accordance with the circular of Aydın Governorship and the security council of Kuşadası District Governorship, whether to install a security camera or not was discussed and the administration was authorized not to install it.

Ertuğul Tunçbilek and Mehmet Oral, among our members, expressed their ideas concerning that entering and coming out of the swimming pool should be taken under control and the residents should abide by the swimming pool regulations.

Fikret Kasapoğlu, one of our new members, gave information about the identity card statements of the new tenants and visitors and demanded that a lamp or strip reflector be put at the entrance of the swimming pool. The administration explained that the identity card data and entrance-exit dates of the visitors and tenants who are not property owners in the site were recorded.

Hikmet-Hamide Hapanıl couple, among our members, stated their complaints about the road and noise and they also stated that the struggle against the weeds around the site was not enough and they demanded more effective precautions be taken.

They also requested that one more fire cabinet be put on their sides like 2 fire cabinets put on the water distribution line between the well and water tank.

Özkan Altuğ, one of our members, raised an objection against the fact that the chairman of the site does not pay any electricity or water charges. Moreover, he stated that the irrigation of the trees alongside the road was not enough.

The following decisions were taken by majority of votes:

1. The dues of the site will continue to be paid as 65.-TL in the upcoming period and the 28.500.-TL well debts, which constitute the remaining balance of the contractor's firm, will be paid as a 3x50.TL additional payment in July-August-September,
2. The administration will take the risk of paying any fee regarding the non-installed security cameras and the administration will be authorized not to install them,
3. 2 more fire cabinets will be placed where the administration deems suitable,
4. A strip reflector will be placed at the entrance of the swimming pool,
5. The Web site of Dağcılar site will be activated,
6. The network coverage of the Internet will be expanded as suggested by one of our members, Fuat Ozantürk, and research will be performed to control whether a connection can be established from each house,
7. The water charge will be reduced to 1 TL./Ton,
8. Tamer Nüfusçu, Ergün Uz, Etem Vahaplar were elected as members of the Managing Body; and Burhan Ayhan and Önal Mısırlıoğlu were elected as the Supervisory Board Members,
9. The members of the managing body will not pay any dues; however, they will pay their own electricity and water charges, on the other hand they will give 35.-TL,
10. The administration plan of the site will be photocopied and sent to each member.


Our new members in the Managing and Supervisory Boards wish the residents of the site health and happiness. Good luck with it for everyone.
